THE SECRETARY-GENERAL'S LETTER OF INVITATION

23 May 2016

Excellency,

In my capacity as the depositary of more than 560 multilateral treaties, I have the honour to invite you to participate in the 2016 Treaty Event. This year, the Treaty Event will be held from 19 to 23 September 2016 at United Nations Headquarters in New York. The first day of the 2016 Treaty Event will coincide with the high-level plenary meeting on addressing Large Movements of Refugees and Migrants, taking place on 19 September. The Event is also designed to take place in conjunction with the General Debate of the seventy-first session of the General Assembly, which opens on 20 September 2016.

The Treaty Event will focus on the theme of human mobility, to underline the commitment of the United Nations to the rights of refugees and migrants at a crucial time. This body of treaty law protects the rights of people on the move, addresses irregular migration, and promotes non-discrimination. It includes treaties relating to refugees, stateless persons, human rights, economic and social rights, and justice and the environment, as well as instruments aimed at combatting trafficking in humans and smuggling of migrants. It is noted that many States maintain reservations on the social and economic rights accorded to refugees, stateless persons and international migrants in various treaties. Lifting these reservations will contribute toward implementation of the 2030 Agenda for Sustainable Development. The Treaty Event will provide a distinct opportunity for States to sign, ratify or accede to multilateral treaties deposited with me, or withdraw reservations to treaties to which they are already party.

I wish to extend this invitation to you to make use of the 2016 Treaty Event by signing treaties for which I act as depositary and by depositing instruments of ratification or accession to those treaties. The treaties which will be highlighted

this year cover the areas of human rights, refugees and stateless persons, health, trade and transport, terrorism and criminal matters, disarmament, climate change and other environmental issues, as well as the safety of United Nations personnel. The Paris Agreement, which opened for signature on 22 April 2016 and garnered a historic record of 175 signatories on its opening, also deals with climate change—related displacement, and is among the highlighted treaties. I urge you to use the Treaty Event to ratify this important Agreement.

A list of the highlighted treaties is enclosed with this letter. I emphasize that the Event may be used to sign and ratify or accede to any other treaty of which I am the depositary. A general list of the treaties deposited with me is available on the website of the Treaty Section of the Office of Legal Affairs (https://treaties.un.org).

Should you wish to participate in the 2016 Treaty Event, kindly inform the Treaty Section of the Office of Legal Affairs, by 2 September 2016, of your intention to sign, ratify or accede to any of the treaties of which I am the depositary, so that the necessary arrangements may be made.

PROCEDURAL INFORMATION LETTER FROM THE LEGAL COUNSEL

1 June 2016

Excellency,

I have the honour to refer to the Secretary-General's letter dated 23 May 2016 inviting Heads of State and Government to participate in this year's Treaty Event which will be held from 19 to 23 September 2016 at the United Nations Headquarters in New York, in conjunction with the high-level plenary meeting on addressing Large Movements of Refugees and Migrants, taking place on 19 September, and with the general debate of the seventy-first session of the General Assembly.

The Treaty Event will highlight treaties deposited with the Secretary-General that cover areas of global concern, including human rights, refugees and stateless persons, health, trade, transport, terrorism, criminal matters, disarmament, environment and the safety of United Nations personnel and associated personnel. The Treaty Event may be used to sign and ratify or accede to any treaty for which the Secretary-General acts as depositary.

It is noted that, consistent with the rules of international law and the practice of the Secretary-General as depositary of multilateral treaties, a Head of State, Head of Government or Minister for Foreign Affairs does not require full powers to execute a treaty action in person. Furthermore, full powers are not required in cases where an instrument conferring general full powers has been issued to a designated person and has been deposited with the Secretary-General in advance.

Where a signature of a treaty deposited with the Secretary-General is to be undertaken by a person other than the Head of State, the Head of Government or the Minister for Foreign Affairs, duly executed full powers are necessary.

The Secretary-General's requirements for a valid instrument of full powers include the following:

- Title of the treaty;
- Full name and title of the person duly authorized to sign the treaty concerned:
- · Date and place of signature; and
- Signature of the Head of State, Head of Government or Minister for Foreign Affairs.

Instruments of ratification, acceptance, approval or accession must also be issued and signed by one of the above three authorities, and should include all declarations and reservations related thereto.

Full powers and instruments of ratification, acceptance, approval or accession should be submitted for verification to the Treaty Section well in advance of the intended date of the relevant treaty action. Further information on full powers and instruments of ratification, acceptance, approval or accession can be obtained from the Treaty Handbook. This document and other publications of the Treaty Section are available online at https://treaties.un.org. The website also provides updated information on the status of all treaties deposited with the Secretary-General.

Advice before 2 September 2016 on your Government's intention to sign, ratify or accede to any of the multilateral treaties deposited with the Secretary-General would assist us in making the necessary arrangements, including appropriate media coverage. It is requested that appointments be made by contacting the Treaty Section of the Office of Legal Affairs (telephone: (212) 963-5047; fax: (212) 963-3693).

We look forward to your Government's participation in the 2016 Treaty Event.

FOREWORD

On 19 September 2016, the United Nations General Assembly will convene a high-level plenary meeting on 'addressing large movements of refugees and migrants'. This event—the first of its kind for the United Nations—will provide an opportunity for States to adopt concrete measures to address the reasons which lead large numbers of people to leave their countries and to respond effectively when they reach their destinations. The Secretary-General's report, *In Safety and Dignity*, spells out a number of recommendations to meet the needs of refugees and migrants in transit and upon arrival, to share responsibilities for refugees more effectively and to strengthen international governance of migration.

In 2015, there were 244 million international migrants and refugees world-wide. Large movements of people are likely to continue and increase as a result of violent conflict, poverty, inequality, climate change, disasters and environmental degradation. Despite valiant efforts, international responses to such movements have too often been inadequate. As the Secretary-General's report emphasizes, individual countries cannot cope with these issues on their own. Our systems of international cooperation and action to address large movements of refugees and migrants must be enhanced. Central to these efforts is the need to strengthen the legal framework governing migration and to reinforce that for refugees.

I am grateful, therefore, that this year's Treaty Event will focus on treaties relating to human mobility as a way of underlining the United Nations' commitment to the rights of refugees and migrants. This body of treaty law protects the rights of people on the move, addresses irregular migration and promotes non-discrimination. It includes treaties relating to refugees, stateless persons, human rights, economic and social rights, justice and the environment, as well as instruments aimed at combatting trafficking and criminal smuggling. Many States maintain reservations on the social and economic rights accorded to refugees, stateless persons and international migrants in various treaties.

The Treaty Event will provide a distinct opportunity for States to sign, ratify or accede to multilateral treaties or withdraw reservations to treaties to which they are already party.

In this respect, my hope is that States will take advantage of this Treaty Event to promote the international legal framework on human mobility. The 19 September High-Level Plenary Meeting is an opportune moment for States and the international community at large to reaffirm their commitment to the rights of all those who cross international borders, whether as refugees or as migrants. Strengthening the international legal framework will improve our ability to address the issues faced by those on the move and to uphold their rights. It is my hope that the Treaty Event will allow—and encourage—States to make a tangible commitment to addressing large movements of refugees and migrants.

TREATIES OPEN FOR SIGNATURE

The following is a selection of treaties which are currently open for signature

A simple signature (signature subject to ratification) is permitted for most multilateral treaties for a specified period of time, though some multilateral treaties remain open for signature indefinitely. By signing, the State has not expressed its consent to be bound by the treaty, which does not occur until the State ratifies, accepts or approves the treaty. However, a signature does mean that a State is obliged, in good faith, to refrain from acts that would defeat the object and purpose of the treaty (article 18 of the Vienna Convention on the Law of Treaties of 1969).
