- **Notification under art. 5(3):** This notification is mandatory at the time of signature or of deposit of their instrument of ratification, etc. for those States whose domestic law requires an act in furtherance of the agreement for purposes of the offences established in accordance with the article.

- **Notification under art. 16(5):** For States that make extradition conditional on the existence of a treaty, shall, at the time of ratification, acceptance, approval or accession, inform the Secretary-General whether they will take this Convention as the legal basis for cooperation on extradition with other States Parties to this Convention.
- **Notification under art. 18(13):** Notification of a designation of a central authority for purposes of receiving mutual legal assistance.
- Notification under art. 18(14): Notification of a designation of language for requests for mutual legal assistance.
- **Notification under art. 31(6):** Notification of an authority that can assist other states in developing measures to prevent transnational organized crime.
