## RECTIFICATION OF THE ENGLISH AND FRENCH TEXTS OF ANNEXES A AND B OF THE AGREEMENT

The Secretary-General of the United Nations, acting in his capacity as depositary of the European Agreement concerning the International Carriage of Dangerous Goods by Road (ADR) done at Geneva on 30 September 1957, communicates the following:

Annexed to this notification is a "Consolidated list of corrections to the text of the 1978 edition (E/ECE/322-E/ECE/TRANS/503/Rev.3) and Amendment 1 (E/ECE/322-E/ECE/TRANS/503/Rev.3/Amend.1) established by the Transport Division of the Economic Commission for Europe.

The said list concerns various rectifications of the text of annexes A and B of the Agreement, which are often of an editorial nature and were approved by the Group of Experts on the Transport of Dangerous Goods (Inland Transport Committee) after consideration of a corresponding proposal by the Secretariat. The list also contains a proposal by the Government of Austria for the rectification of marginal 2501 (annex A).

Unless an objection by a signatory or a Contracting State is notified to him within 90 days from the date of the present notification, the Secretary-General proposes to effect the corresponding corrections in the English and French texts of annexes A and B of the Agreement.


