AGREEMENT ESTABLISHING THE ASIA-PACIFIC INSTITUTE FOR
BROADCASTING DEVELOPMENT
CONCLUDED AT KUALA LUMPUR ON 12 AUGUST 1977

PROPOSED AMENDED TEXT OF THE AGREEMENT

The Secretary-General of the United Nations, acting in his capacity as depositary, and referring to depositary notification C.N.380.TREATIES-1 of 31 December 1983, communicates the following:

At its Eleventh Meeting, held in New Delhi from 25 to 29 June 1985, the Governing Council of the Asia-Pacific Institute for Broadcasting Development approved the proposed amended English text of the above-mentioned Agreement, and resolved unanimously to request the Secretary-General to establish Chinese, French and Russian texts of the Agreement, as amended, and to circulate the said texts.

The Governing Council further decided that the said texts would be deemed to have been accepted (within the meaning of article 13 of the original Agreement and of article 15 (1) of the proposed amended Agreement), by all signatories and Contracting Parties unless objections to the said proposed texts were made and notified to the Secretary-General within 90 days from the date of the circulation of the said texts or unless within the same period of time objections were made to the said procedure. Unless objections are received as indicated above, the Secretary-General will consider that the said texts have been adopted and that, in accordance with its article 17, the amended Agreement shall enter into force on the expiry of the said 90 day period, at which time the amended Agreement will replace the original Agreement. Further signatures, ratifications, acceptances or accessions will be deemed effected in respect of the amended Agreement in accordance with article 15 (2) and 16 (1).

In accordance with the above-mentioned decisions of the Governing Council, the signatories and Contracting Parties to the Agreement will find annexed hereto, the amended text of the Agreement in the Chinese, English, French and Russian languages as established by the Secretary-General.
