PROCES-VERBAL CONCERNING MODIFICATIONS TO
REGULATION NO. 21 ANNEXED TO THE AGREEMENT

The Secretary-General of the United Nations, acting in his capacity as depositary, and referring to Regulation No. 21 annexed to the Agreement, communicates the following:

The Group of Experts on the Construction of Vehicles of the Inland Transport Committee of the Economic Commission for Europe has notified the Secretariat of modifications to be effected in the English and French texts of the said Regulation, as revised and amended (see documents TRANS/SC1/WP29/R.174, R.174/Add.1 and R.174/Amend.1 circulated by depositary notification C.N.120.1980.TREATIES-6 of 8 May 1980 and E/ECE/324-E/ECE/TRANS/505/Rev.1/Add.20/Rev.1, circulated by the Economic Commission for Europe; and TRANS/SC1/WP29/113 circulated by depositary notification C.N.310.1985.TREATIES-40 of 26 November 1985 and E/ECE/324-E/ECE/TRANS/505/Rev.1/Add.20/Rev.1/Amend.1 circulated by the Economic Commission for Europe).
