## FINAL CLAUSES

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

The above-mentioned Agreement, of which the Arabic, English, French, Russian and Spanish texts are equally authentic, was adopted on 25 July 1986 at Geneva by the United Nations Conference on Cocoa, 1986. The Agreement is open for signature at the United Nations Headquarters from 1 September until and including 30 September 1986, by parties to the International Cocoa Agreement, 1980, and any Government invited to the United Nations Cocoa Conference, 1984, in accordance with its article 65.

II

Certified true copies of the Agreement are being prepared and will be communicated as soon as possible to States and organizations concerned.

For the ease of reference, the text of the final clauses of the Agreement (articles 4 (1), 65, 66, 67, 68, 69, 70, 71, 72, 73, 74, 75, 76, 77, the testimonium and Annexes D and E) are . . . . . reproduced separately as an annex hereto.
