DECISION 2 (IX) RENEGOTIATION OF THE AGREEMENT

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

In accordance with article 46 of the Agreement, the International Jute Council, under its decision 2 (IX) taken during its 9th session held on 16 - 20 March 1988 in Dhaka, has decided to renegotiate the said Agreement.

The process of renegotiation will be initiated at the Council's 10th session to be held at New Delhi from 4 - 8 November 1988.

The text of the above-mentioned decision is annexed hereto.
