INTERNATIONAL COCOA AGREEMENT, 1986 CONCLUDED AT GENEVA ON 25 JULY 1986

PROCES-VERBAL OF RECTIFICATION OF THE ORIGINAL OF THE AGREEMENT (CHINESE TEXT) AND OF THE CERTIFIED TRUE COPIES

The Secretary-General of the United Nations, acting in his capacity as depositary, and referring to depositary notification C.N.285.1987.TREATIES-15 of 14 December 1987 concerning the proposed corrections in respect of the original (Chinese text) of the Agreement, and of the certified true copies, communicates the following:

Within a period of 90 days from the date of the above-mentioned depositary notification, no objection to the proposed corrections had been notified by any of the Parties concerned. Consequently, the Secretary-General has caused, on 13 March 1988, the appropriate corrections to be effected in the Chinese original of the Agreement. A copy of the corresponding Procès-verbal of rectification, which also applies to the certified true copies of the Agreement established on 3 September 1986 and transmitted by depositary notification C.N.190.1986.TREATIES 2 of 30 September 1986, is enclosed.
