The Secretary-General of the United Nations, acting in his capacity as depositary, and referring to depositary notification C.N.315.1987.TREATIES-6 of 29 January 1988 concerning proposed corrections in respect of the original (Arabic, Chinese, English, French and Russian texts) of the Agreement, and of the certified true copies, communicates the following:

Within a period of 90 days from the date of the above-mentioned depositary notification, no objection to the proposed corrections had been notified by any of the Parties concerned. Consequently, the Secretary-General has caused, on 28 April 1988, the appropriate corrections to be effected in the Arabic, Chinese, English, French and Russian originals of the Agreement.
