THE SECRETARY-GENERAL OF THE UNITED NATIONS, acting in his capacity as depositary of the above Agreement,

WHEREAS the Administrative Committee of the above Agreement, at its twenty-fifth session, adopted certain drafting modifications to Regulation No. 44 ("Uniform provisions concerning the approval of restraining devices for child occupants of power-driven vehicles ("child restraint system") (TRANS/WP.29/972),

HAS CAUSED the said modifications, listed in the annex to this Procès-verbal, to be effected in the English and French texts of Regulation No. 44.
