ADOPTION OF AMENDMENTS TO REGULATION NO. 48<sup>1</sup>

Within the period of six months following the date of depositary notification  
C.N.298.2006.TREATIES-1 of 10 April 2006, none of the Contracting Parties applying Regulation No.  
48 expressed disagreement with the proposed amendments. Therefore, in accordance with paragraph 2  
of article 12 of the Agreement, the proposed amendments are considered to be adopted and are binding  
upon all Contracting Parties applying Regulation No. 48 as of 10 October 2006.
