ADOPTION OF AMENDMENTS TO REGULATION NO. 26¹

C.N.1168.2006.TREATIES-1 of 11 December 2006, none of the Contracting Parties applying
Regulation No. 26 expressed disagreement with the proposed amendments. Therefore, in accordance
with paragraph 2 of article 12 of the Agreement, the proposed amendments are considered to be
adopted and are binding upon all Contracting Parties applying Regulation No. 26 as of 11 June 2007.
