ADOPTION OF AMENDMENTS TO REGULATION NO. 51¹

with paragraph 2 of article 12 of the Agreement, the proposed amendments are considered to be
adopted and are binding upon all Contracting Parties applying Regulation No. 51 as of 18 June 2007.
