WHEREAS the Administrative Committee of the above Agreement, at its thirty-eighth session, adopted certain drafting modifications to Regulation No. 98 ("Uniform provisions concerning the approval of motor vehicle headlamps equipped with gas-discharge light sources") (ECE/TRANS/WP.29/2008/51),

HAS CAUSED the said modifications to be effected in the English and French texts of Regulation No. 98.
