WHEREAS the Administrative Committee of the above Agreement, at its thirty-ninth session, adopted certain drafting modifications to Regulation No. 41 ("Uniform Provisions concerning the approval of motor cycles with regard to noise") (ECE/TRANS/WP.29/2008/67),
