WHEREAS the Administrative Committee of the above Agreement, at its thirty-ninth session, adopted certain drafting modifications to Regulation No. 117 ("Uniform provisions concerning the approval of tyres with regard to rolling sound emissions and to adhesion on wet surfaces") (ECE/TRANS/WP.29/2008/68),

HAS CAUSED the said modifications to be effected in the English and French texts of Regulation No. 117.
