ENTRY INTO FORCE OF REGULATION NO. 143 ¹

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

Within the period of six months from the date of depositary notification C.N.919.2016.TREATIES-XI.B.16 of 19 December 2016 by which the Secretary-General transmitted to the Governments of the Contracting Parties the text of the draft regulation, two Contracting Parties to the Agreement notified their disagreement with the draft regulation ².

Therefore, in accordance with article 1 (3) of the Agreement, the draft regulation is adopted as Regulation No. 143 annexed to the above Agreement. In accordance with article 1 (4) of the Agreement, the date of its entry into force for all Contracting Parties, with the exception of Australia and Japan, is 19 June 2017.
