ENTRY INTO FORCE OF UNITED NATIONS REGULATION No. 144 ¹

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

Within the period of six months from the date of depositary notification C.N.24.2018.TREATIES-XI.B.16 of 19 January 2018 by which the Secretary-General transmitted to the Governments of the Contracting Parties the text of draft UN Regulation No. 144, none of the Contracting Parties to the Agreement have informed the Secretary-General of their disagreement with the draft UN Regulation, or their intention not to apply it on the date of its entry into force.

Therefore, in accordance with article 1 (3) of the Agreement, the draft UN Regulation is adopted as UN Regulation No. 144. In accordance with article 1 (4) of the Agreement, the date of entry into force of UN Regulation No. 144 for all Contracting Parties is 19 July 2018.
