This panel is being organized in light of the second anniversary of the adoption of the International Convention for the Suppression of Acts of Nuclear Terrorism, and in preparation for this year's treaty event entitled *Focus 2007: A Comprehensive Legal Framework for Peace, Development and Human Rights*, which is scheduled to be held from 25 to 27 September 2007 and 1 to 2 October 2007 at United Nations Headquarters. On this occasion, an opportunity will be provided to Member States, at the highest level of Government, which have not already done so, to ratify or accede to any of the five treaties relating to terrorism, as well as to any of the other multilateral treaties deposited with the Secretary-General.
