
Sir,

I have the honour, upon instructions from the Secretary-General, to refer to letter C.N.70.1972.TREATIES-2 of 9 June 1972, informing you of the deposit by the Government of Indonesia of its instrument of accession with reservations to the Convention on the Privileges and Immunities of the United Nations, approved by the General Assembly of the United Nations on 13 February 1946.

I wish to inform you that, on 21 September 1972, the Secretary-General received the following communication from the Permanent Representative of the United Kingdom to the United Nations with reference to one of the above-mentioned reservations relating to article VIII of section 30 of the Convention:

"The United Kingdom Government wish to put on record that they are unable to accept this reservation because, in their view, it is not of the kind which intending parties to the Convention have the right to make."
