CONVENTION ON ROAD TRAFFIC
DONE AT VIENNA ON 8 NOVEMBER 1968

ACCESSION BY NIGER

Sir,

I have the honour, upon instructions from the Secretary-General, to inform you that, on 11 July 1975, the instrument of accession by the Government of Niger to the Convention on Road Traffic, done at Vienna on 8 November 1968, was deposited with the Secretary-General.

On depositing the above-mentioned instrument the Government of Niger notified the Secretary-General, with reference to paragraph 4 of article 45 of the Convention, that it intended to keep the distinguishing sign "RN" for display in international traffic on vehicles registered by it.
