CONVENTION ON THE LIMITATION PERIOD IN THE INTERNATIONAL SALE
OF GOODS CONCLUDED AT NEW YORK ON 12 JUNE 1974TRANSMISSION OF A PROCES-VERBAL OF RECTIFICATION OF
THE FRENCH ORIGINAL OF THE CONVENTION

Sir,

I have the honour, upon instructions from the Secretary-General, to refer to letter C.N.120.1975.TREATIES-2 of 27 May 1975, by which the Secretary-General proposed a correction to be effected in the French original of the Convention on the Limitation Period in the International Sale of Goods, concluded at New York on 12 June 1974.

No objections having been received from the States concerned within 90 days from the date of the above-mentioned letter, the French original of the Convention was corrected accordingly, and I am transmitting herewith the corresponding Procès-Verbal of rectification.
