EUROPEAN AGREEMENT CONCERNING THE WORK OF
CREWS OF VEHICLES ENGAGED IN INTERNATIONAL
ROAD TRANSPORT (AETR)
DONE AT GENEVA ON 1 JULY 1970

AMENDMENTS PROPOSED BY THE UNITED KINGDOM
OF GREAT BRITAIN AND NORTHERN IRELAND TO ARTICLES 3, 6, 10,
11, 12 AND 14 OF THE AGREEMENT:

NOTIFICATION BY CZECHOSLOVAKIA UNDER ARTICLE 23 (2) (b)
OF THE AGREEMENT

The Secretary-General of the United Nations, acting in his capacity as depositary, and referring to depositary notification C.N.399.1981.TREATIES-1 of 2 February 1982 communicating the text of certain amendments proposed by the Government of the United Kingdom of Great Britain and Northern Ireland to articles 3, 6, 10, 11, 12 and 14 of the European Agreement concerning the Work of Crews of Vehicles Engaged in International Road Transport (AETR), done at Geneva on 1 July 1970, communicates the following:

In a communication received on 30 July 1982, the Government of Czechoslovakia notified the Secretary-General, in accordance with article 23 (2) (b) of the above-mentioned Agreement, that although it intended to accept the proposal of the Government of the United Kingdom, the conditions necessary for such acceptance were not yet fulfilled in respect of Czechoslovakia.

In view of the above, and in keeping with the provisions of paragraphs 2 to 7 of article 23, the proposed amendments will be deemed to have been accepted if, before the expiry of a period of nine months following the expiry of the period of six months

resulting from depositary notification C.N.399.1981.TREATIES-1 of 2 February 1982, i.e., before 3 May 1983, the Government of Czechoslovakia has not notified an objection to the said proposed amendments (unless the Government of Czechoslovakia notifies its acceptance before 3 May 1983, in which case the amendments will be deemed to be accepted on the date of such acceptance). The Secretary-General will not fail to inform all States concerned of any development in this respect.

It will be recalled that a similar notification concerning the proposed amendments was received from the Government of the Netherlands and circulated by depositary notification C.N.189.1982.TREATIES-2 of 19 August 1982.
