Amendments to Annex 1 scheduled for entry into force on 13 February 1983

RECTIFICATION OF THE FRENCH TEXT OF THE AMENDMENTS
PROPOSED BY THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN
AND NORTHERN IRELAND AS CIRCULATED UNDER COVER OF DEPOSITARY
NOTIFICATION C.N.65.1981.TREATIES-2 OF 12 MAY 1981

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

In a communication dated 1 December 1982, the Government of the Netherlands drew the attention of the Secretariat to an error that appears in the French text of the above-mentioned amendments as circulated under cover of depositary notification C.N.65.1981.TREATIES-2 of 12 May 1981.

Actually, the last sentence of paragraph 4 (Annex 1, Appendix 1) of the French text should be completed as follows:

"4. ... Si un engin ne peut être désigné comme faisant partie d'une catégorie ou d'une classe qu'en application des dispositions transitoires prévues au paragraphe 5 de la présente annexe, la validité de l'attestation délivrée à cet engin sera limitée à la période prévue à ces dispositions transitoires."

The above-quoted text conforms to the text of the amendment as approved by the Group of Experts on the Transport of Perishable Foodstuffs of the Inland Transport Committee, Economic Commission for Europe (doc. TRANS/GE.11/15 of 17 December 1979).

Consequently, and unless there are objections on the part of the States concerned, it will be understood that the amendment will enter into force on 13 February 1983 in its corrected form.
