COMPLEMENTARY DECLARATION BY THE FEDERAL REPUBLIC OF GERMANY

The Secretary-General of the United Nations, acting in his capacity as depositary, and referring to depositary notification C.N.78.1984.TREATIES-2 of 16 July 1984 concerning, *inter alia*, an objection by the Government of the Federal Republic of Germany to the amendments proposed by the United Kingdom of Great Britain and Northern Ireland to annexes 2 and 3 of the above-mentioned Agreement, communicates the following:

On 6 August 1984, the Secretary-General received the following complementary declaration by the Government of the Federal Republic of Germany in regard to the above-mentioned objection:

The Government of the Federal Republic of Germany raises no objections to the new footnote (4) proposed by the United Kingdom of Great Britain and Northern Ireland under annex 3 (b) of the Agreement of 1 September 1970 (ATP) on the International Carriage of Perishable Foodstuffs and on the Special Equipment to be Used for Such Carriage (C.N.318.1983.TREATIES-4 of 20 October 1983).

Taking into account the above-mentioned communication by the Federal Republic of Germany, the communication by France received on 20 April 1984 and the complementary communication received from Morocco on 28 June 1984, as set out in C.N.78.1984.TREATIES-2 of 16 July 1984, the amendment proposed by the United Kingdom of Great Britain and Northern Ireland concerning a new footnote (4) under annex 3 (b) of the Agreement (definition of the term "fresh cheese") will enter into force on 20 January 1985, i.e. nine months following the expiry of the period of six months after the date on which the proposed amendment was communicated by the Secretary-General, unless before that date the Government of France submits an objection to the proposed amendment or alternatively it accepts the amendment, in which case the amendment will enter into force on the date when the Secretary-General is notified of the acceptance, in accordance with paragraphs 3 and 5 of article 18 of the Agreement.
