UNITED NATIONS CONVENTION ON THE LAW OF THE SEA
CONCLUDED AT MONTEGO BAY, JAMAICA,
ON 10 DECEMBER 1982PROCES-VERBAL OF RECTIFICATION OF THE ORIGINAL OF THE FINAL ACT
OF THE THIRD UNITED NATIONS CONFERENCE ON THE LAW OF THE SEA,
SIGNED AT MONTEGO BAY, JAMAICA, ON 10 DECEMBER 1982

The Secretary-General of the United Nations, acting in his capacity as depositary, and referring to depositary notifications C.N.6.1985.TREATIES-1 of 3 June 1985 concerning, *inter alia*, proposed corrections in respect of the original of the Final Act and the addition of Annex VII, and C.N.233.1985.TREATIES-20 of 28 October 1985 concerning further proposed corrections in respect of the original (Arabic, Chinese, English, French and Spanish texts only) of the said Final Act, communicates the following:

No objection to the said proposed corrections and to the addition of Annex VII having been notified by any of the interested Parties, within a period of 90 days from the date of depositary notifications C.N.6.1985.TREATIES-1 of 3 June 1985 and C.N.233.1985.TREATIES-20 of 28 October 1985, the Secretary-General has caused the appropriate corrections and addition to be effected in the original of the Final Act.

A copy of the corresponding Procès-verbal of rectification is enclosed together with the text of the corrections and of Annex VII, which corrections and addition also apply to the certified true copies of the Final Act established on 29 January 1985 and transmitted by the above-mentioned depositary notification C.N.6.1985.TREATIES-1 of 3 June 1985.
