AGREEMENT ESTABLISHING THE ASIA-PACIFIC INSTITUTE FOR
BROADCASTING DEVELOPMENT
CONCLUDED AT KUALA LUMPUR ON 12 AUGUST 1977

ADOPTION OF THE AMENDED TEXT OF THE AGREEMENT

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

By depositary notification C.N.130.1986.TREATIES-1 of 13 June 1985, the Secretary-General circulated, in accordance with a request of the Governing Council of the Asia-Pacific Institute for Broadcasting Development to that effect, a proposal for the adoption of the English text of the Agreement including the amendments approved by the Council, and also of the corresponding Chinese, French and Russian texts of the Agreement as established by the Secretary-General, also upon the request of the Council.

Within a period of 90 days from the date of the said depositary notification, no objection to the above-mentioned proposed adoption nor to the procedure applied had been notified by any of the Signatory or contracting States. Consequently, on 11 September 1986, the Secretary-General has considered that the English, Chinese, French and Russian texts of the Agreement as amended had been adopted, as authentic texts.

..... transmit herewith two certified true copies of the said Agreement, as amended.

The Secretary-General takes this opportunity to call the attention of the competent authorities to the fact that certified true copies are established specifically for the purpose of enabling the Governments and Organizations concerned to complete the internal procedures of ratification, acceptance, approval or accession. For budgetary reasons, certified true copies are printed in limited numbers, and it is expected that any additional copies that may be required could be reproduced by the authorities concerned themselves on the basis of the two copies accompanying the present communication.
