BYELORUSSIAN SOVIET SOCIALIST REPUBLIC

The Byelorussian Soviet Socialist Republic does not consider itself bound by article 8 of the European Agreement on Main International Railway Lines of 31 May 1985 and declares that the agreement of all the parties to a dispute is required, in each specific case, for the submission to arbitrators of any

dispute between Contracting Parties relating to the interpretation or application of the European Agreement, and that only persons designated by mutual agreement between the parties to a dispute may act as arbitrators.
