PROCES-VERBAL OF RECTIFICATION OF THE ORIGINAL OF THE CONVENTION
(FRENCH TEXT) AND OF THE CERTIFIED TRUE COPIES

The Secretary-General of the United Nations, acting in his capacity as depositary, and referring to depositary notification C.N.103.1987.TREATIES-5 of 17 July 1987 concerning the proposed corrections in respect of the original (French text) of the Convention, and of the certified true copies, communicates the following:

Within a period of 90 days from the date of the above-mentioned depositary notification, no objection to the proposed corrections had been notified by any of the Parties concerned. Consequently, the Secretary-General has caused, on 16 October 1987, the appropriate corrections to be effected in the French original of the Convention. A copy of the corresponding Procès-verbal of rectification, which also applies to the certified true copies of the Convention established on 17 April 1986 and transmitted by depositary notification C.N.87.1986.TREATIES-2 of 14 May 1986, is enclosed.
