CORRIGENDUM TO DEPOSITARY NOTIFICATION C.N.209.1987.TREATIES-6
OF 8 OCTOBER 1987

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On page 2, line 6, of the Annex to depositary notification C.N.209.1987.TREATIES-6 of 8 October 1987, and with reference to a correction to be made in the Russian text of article 6, paragraph 5, of the Convention, it was indicated that "the reference "lb" at the end of the first line" of the said paragraph should be "deleted".

In fact, the correction in question should have indicated:

"Delete the reference "lb" at the end of the first line and insert it at the end of the second line."
