NOTIFICATION BY PAKISTAN

The Secretary-General of the United Nations, acting in his capacity as depositary, and referring to depositary notification C.N.78.1986.TREATIES-2 of 28 April 1986 concerning the accession by the Government of Pakistan to the above-mentioned Convention, communicates the following:

On 23 February 1987, the Government of Pakistan notified the Secretary-General, in keeping with article 45 (4) of the Convention, that it had selected the distinguished sign "PK" for display in international traffic on vehicles registered by it.
