APPROVAL BY FRANCE

FULFILLMENT OF THE CONDITIONS REQUIRED UNDER ARTICLE 6 (1)
FOR THE ENTRY INTO FORCE OF THE AGREEMENT

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

I

On 27 January 1989, the instrument of approval by the Government of France of the above-mentioned Agreement was deposited with the Secretary-General.

II

Upon deposit of the instrument of approval by the Government of France, the conditions provided for in article 6 (1) of the Agreement were met, and accordingly the Convention will enter into force on 27 April 1989, i.e. the ninetieth day after the date of deposit of the said instrument in accordance with article 6 (1).
