ACCESSION BY CZECHOSLOVAKIA

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

With reference to depositary notification C.N.20.1990.TREATIES-1 of 15 March 1990 concerning the accession by the Government of Yugoslavia to the above-mentioned Agreement, the Government of Yugoslavia, on 20 April 1990, in accordance with article 13 of the Agreement, has informed the Secretary-General that the administration to which proposed amendments to the annexes of the Agreement should be transmitted is:

On 10 May 1990, the instrument of accession by the Government of Czechoslovakia to the above-mentioned Agreement was deposited with the Secretary-General.

The instrument of accession contains a reservation to the effect that Czechoslovakia shall not consider itself bound by article 8 of the Agreement.

In a note accompanying the instrument of accession, the Government of Czechoslovakia has informed the Secretary-General, in accordance with article 13 of the Agreement, that the administration to which proposed amendments to the annexes of the Agreement should be transmitted is the Federal Ministry of Transportation of the Czech and Slovak Federal Republic.

In accordance with article 6 (2), the Agreement will enter into force for Czechoslovakia on 8 August 1990, i.e. the ninetieth day after the date of the deposit of its instrument.
