ACCESSION BY YUGOSLAVIA

On 31 January 1990, the instrument of accession by the Government of Yugoslavia to the above-mentioned Agreement was deposited with the Secretary-General.

In accordance with article 6 (2), the Agreement will enter into force for Yugoslavia on 1 May 1990, i.e. the ninetieth day after the date of the deposit of its instrument.
