CONVENTION ON ROAD TRAFFIC CONVENTION ON ROAD SIGNS AND SIGNALS CONCLUDED AT VIENNA ON 8 NOVEMBER 1968

ACCESSION BY LITHUANIA

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 20 November 1991, the instrument of accession by the Government of Lithuania to the above-mentioned Conventions was deposited with the Secretary-General.

The said instrument contains the following reservation in respect of the Convention on Road Traffic:

(Original: English)

"The Republic of Lithuania does not consider itself bound by Article 52 of the Convention."

On depositing its instrument, the Government of Lithuania also notified the Secretary-General that:

(Original: English)

"In accordance with Paragraph 4. Article 45 of the Convention, the Republic of Lithuania chooses distinguishing sign LT, which belonged to the Republic of Lithuania till its annexation.".

The said instrument contains the following reservation in respect of the Convention on Road Signs and Signals:

(Original: English)

"The Republic of Lithuania ... does not consider itself bound by Article 44 of the Convention."

On depositing its instrument, the Government of Lithuania also notified the Secretary-General that:

(Original: English)

"Following paragraph 2, Article 46 of the Convention, the Republic of Lithuania declares that it chooses the model Aa as a danger warning sign and the model B, 2a as a stop sign.".

In accordance with their articles 47 (2) and 39 (2), respectively, the Conventions will enter into force for Lithuania twelve months after the date of deposit of the instrument, i.e. on 20 November 1992.
