INTERNATIONAL AGREEMENT ON OLIVE OIL
AND TABLE OLIVES, 1986
CONCLUDED AT GENEVA ON 1 JULY 1986

EXTENSION OF THE TIME-LIMIT FOR DEPOSIT OF INSTRUMENTS OF RATIFICATION,
ACCEPTANCE, APPROVAL OR ACCESSION BY ISRAEL, LEBANON AND MOROCCO

MODIFICATION TO ARTICLE 17 (1) OF THE AGREEMENT

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

I

The International Olive Oil Council, by Resolution No. RES-2/66-IV/92 of 28 May 1992, adopted at its sixty-sixth session, held in Madrid from 25 to 29 May 1992, decided, in accordance with articles 52 (3) and 53 (1) of the Agreement, to extend until 31 December 1992 the time-limit granted to the Governments of Israel, Lebanon and Morocco for the deposit of the instruments of ratification, acceptance, approval or accession.

II

At the same session, by Resolution No. RES-1/66-IV/92 of 27 May 1992, the International Olive Oil Council, in accordance with article 17 (2) of the Agreement, decided to raise the sum fixed in article 17 (1) of the Agreement from 300,000 to 600,000 United States dollars for the implementation of programmes of technical cooperation in olive oil cultivation, olive oil extraction and table olive processing, with effect from 1 January 1994.
