TERMS OF REFERENCE OF THE INTERNATIONAL COPPER STUDY GROUP,
AS ADOPTED ON 24 FEBRUARY 1989
BY THE UNITED NATIONS CONFERENCE ON COPPER, 1988

ENTRY INTO FORCE OF THE AMENDMENTS TO PARAGRAPHS 13
AND 14 OF THE TERMS OF REFERENCE

TRANSMISSION OF THE TEXT OF THE SAID AMENDMENTS

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

I

At its inaugural session, held in Geneva from 22 to 26 June 1992, the members of the International Copper Study Group decided by consensus (Decision 1 (I)) to amend paragraphs 13 and 14 of the above-mentioned Terms of Reference pursuant to article 21 thereof.

By 15 August 1992, no objections were received by the depositary on the entering into force of the amendments. Therefore, in accordance with paragraph 2 of the above-mentioned Decision, the amendments to paragraphs 13 and 14 entered into force on that date.

II

In accordance with paragraph 4 of the above-mentioned Decision 1 (I), the Arabic, Chinese, English, French, Russian and Spanish versions of the said amendments are being

In accordance with paragraph 5 of the said Decision, the certified true copies of the Terms of Reference, as amended, are being established and will be circulated as soon as possible.
