CONVENTION ON ROAD TRAFFIC CONVENTION ON ROAD SIGNS AND SIGNALS

CONCLUDED AT VIENNA ON 8 NOVEMBER 1968

ACCESSION BY LATVIA

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 19 October 1992, the instrument of accession by the Government of Latvia to the above-mentioned Conventions was deposited with the Secretary-General.

I

The instrument contains the following declaration in respect of the Convention on Road Traffic:

(Original: English)

"According to Paragraph 4, Article 45, of the Convention on Road Traffic, the Republic of Latvia chooses the distinguishing sign 'LV'.".

Also, the instrument contains the following declaration in respect of the Convention on Road Signs and Signals:

(Original: English)

"According to Paragraph 2, Article 46, of the Convention on Road Signs and Signals, the Republic of Latvia declares that it chooses the model B, 2a as a stop sign ... [and] the model Aa as a danger warning sign.".

In accordance with their articles 47 (2) and 39 (2), respectively, the Conventions will enter into force for Latvia twelve months after the date of deposit of the instrument, i.e. on 19 October 1993.
