CONSTITUTION OF THE UNITED NATIONS INDUSTRIAL DEVELOPMENT ORGANIZATION CONCLUDED AT VIENNA ON 8 APRIL 1979

ACCESSION BY GEORGIA

DENUNCIATION BY CANADA

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 30 October 1992, the instrument of accession by the Government of Georgia to the above-mentioned Constitution was deposited with the Secretary-General.

In accordance with its article 25 (2) (c), the Constitution entered into force for Georgia on the date of deposit of its instrument, i.e. on 30 October 1992.

On 3 December 1992, the Government of Canada deposited with the Secretary-General an instrument of denunciation of the said Constitution. (In this connexion, reference is made to depositary notification C.N.296.1983.TREATIES-13 of 30 September 1983 concerning the ratification by Canada of the Constitution.)

In accordance with its article 6 (2), the denunciation will take effect on the last day of the fiscal year following that during which such instrument was deposited, i.e. on 31 December 1993.
