SUCCESSION BY SLOVAKIA

COMMUNICATION BY SLOVAKIA
UNDER ARTICLE 45 (4) OF THE CONVENTION

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 1 February 1993, the notification of succession by the Government of Slovakia to the above-mentioned Convention was deposited with the Secretary-General, with effect from 1 January 1993, the date on which Slovakia assumed responsibility for its international relations.

At the same time and in pursuance of article 45 (4) of the Convention, the Government of Slovakia also notified the Secretary-General that it had selected the distinguishing sign "SQ" for display in international traffic on vehicles registered by it.

Subsequently, that is on 14 April 1993, the Government of Slovakia notified the Secretary-General that it has now replaced the distinguishing sign "SQ" previously selected with the distinguishing sign "SK".
