RECTIFICATION OF THE ORIGINAL OF THE FINAL ACT OF
THE THIRD UNITED NATIONS CONFERENCE ON THE LAW
OF THE SEA AND OF THE CERTIFIED TRUE COPIES

The Secretary-General of the United Nations, acting in his capacity as depositary, and referring to depositary notification C.N.460.1992.TREATIES-2 of 1 March 1993 concerning a proposed correction in respect of the original of the Final Act of the Third United Nations Conference on the Law of the Sea and of the certified true copies thereof, communicates the following:

Within a period of 90 days from the date of the above-mentioned depositary notification, no objection to the proposed corrections had been notified by any of the Parties concerned. Consequently, the Secretary-General has caused, on 30 May 1993 the appropriate correction to be effected in the original of the Final Act. THE SECRETARY-GENERAL OF THE UNITED NATIONS,
acting in his capacity as depositary of the
United Nations Convention on the Law of the
Sea, concluded at Montego Bay, Jamaica on 10
December 1982,

LE SECRETAIRE GENERAL DE L'ORGANISATION DES

WHEREAS it has been noticed that the original
of the Final Act of the Third United Nations
Conference on the Law of the Sea contains a
misprint: that in paragraph 10 (a), line 5,
the words "as provided for in subparagraph
(c) should read "as provided for in
subparagraph (b)" (emphasis added),

CONSIDERANT qu'il est apparu que l'original
de l'Acte Final de la Troisième Conférence
des Nations Unies sur le droit de la mer
comporte une erreur d'impression, à savoir
qu'au paragraphe 10 a), ligne 5, au lieu de
"comme prévu à la lettre c) il aurait fallu
lire "comme prévu à la lettre b)" (non
souligné dans le texte).

WHEREAS the corresponding proposed correction
was communicated to all States concerned by
depository notification C.N.460.1992.
TREATIES-2 of 1 March 1993,

CONSIDERANT que la proposition de correction
correspondante a été communiquée à tous les
Etats intéressés par notification dépositaire
C.N.460.1992.TREATIES-2 du 1er mars 1993,

WHEREAS at the end of a period of 90 days
from the date of that communication, no
objection to the proposed correction had been
notified,

CONSIDERANT que dans le délai de 90 jours à
compter de la date de cette communication,
aucune objection à cette proposition de
correction n'a été notifiée,

HAS CAUSED the required correction to be
effected in the original of the Final Act of
the Third United Nations Conference on the
Law of the Sea, which correction also applies
to the certified true copies of the Final Act
established on 16 March 1983.
