The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 26 May and 14 June 1993, respectively, the instrument of accession by the Governments of the Republic of Moldova and Turkmenistan to the Convention on Road Traffic were deposited with the Secretary-General.

In accordance with article 45 (4) of the Convention on Road Traffic, the Government of Turkmenistan has indicated that it has selected the distinguishing sign 'TMN' for display in international traffic on vehicles registered by it.

In accordance with its article 47 (2), the Convention will enter into force for the States concerned twelve months after the date of deposit of the respective instruments, i.e. for the Republic of Moldova on 26 May 1994 and for Turkmenistan on 14 June 1994.

On 14 June 1993, the instrument of accession by the Government of Turkmenistan to the Convention on Road Signs and Signals was deposited with the Secretary-General.

In accordance with its article 39 (2), the Convention will enter into force for Turkmenistan twelve months after the date of deposit of the instrument, i.e. on 14 June 1994.
