At its ninety-eighth session, the Working Party on the Construction of Vehicles, Principal Working Party on Road Transport, of the Inland Transport Committee of the Economic Commission for Europe, adopted certain drafting modifications to the English text of Regulation No. 16 ("Uniform provisions concerning the approval of safety belts and restraint systems for adult occupants of power-driven vehicles") (E/ECE/324-E/ECE/TRANS/505/Rev.1/Add.15/Rev.1), as previously revised and amended.
