CONVENTION ON ROAD TRAFFIC
CONCLUDED AT VIENNA ON 8 NOVEMBER 1968

SUCCESSION BY THE FORMER YUGOSLAV REPUBLIC OF MACEDONIA

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 18 August 1993, the notification of succession by the former Yugoslav Republic of Macedonia to the above-mentioned Convention, with effect from 17 September 1991, the date on which the former Yugoslav Republic of Macedonia assumed responsibility for its international relations, was deposited with the Secretary-General.

In pursuance of article 45 (4) of the Convention, the Government of the former Yugoslav Republic of Macedonia has also notified the Secretary-General that it has selected the distinguishing sign "MK" for display in international traffic on vehicles registered by it.
