### COMMUNICATION BY UKRAINE

CONVENTION ON ROAD SIGNS AND SIGNALS CONCLUDED AT VIENNA ON 8 NOVEMBER 1968

#### COMMUNICATION BY TURKMENISTAN

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

]

On 21 October 1993, the Secretary-General received from the Government of Ukraine, in accordance with article 45 (4), a notification concerning the decision "to replace the distinguishing sign [SU] chosen by Ukraine on its ratification in 1974 of the 1968 Convention on Road Traffic with a new distinguishing sign 'UA'." (In this connexion, reference is made to depositary notification C.N.158.1974.TREATIES-2 of 20 August 1974 concerning the ratification, on 12 July 1974, by Ukraine of the said Convention.)

In accordance with article 54 (4) of the Convention, the modification will take effect three months after the date of receipt of the said notification, i.e. on 21 January 1994.

On 11 October 1993, the Secretary-General received from the Government of Turkmenistan a communication, in accordance with article 46 (2) of the 1968 Convention on Road Signs and Signals, notifying "that Turkmenistan has chosen the model Aa as a danger warning sign, and the model B, 2a as a stop sign". (In this connexion, reference is made to depositary notification C.N.211.1993.TREATIES-4/1 of 28 August 1993 concerning the accession by Turkmenistan, on 14 June 1993, to the said Convention.)
