The International Olive Oil Council, by Resolution No. RES-2/68-IV/93, adopted at Madrid on 11 April 1994, in accordance with article 60 (3) of the Protocol, has decided to extend until 30 June 1994 the time-limit for the deposit of instruments of ratification, acceptance or approval by signatory Governments.

III

On 25 March 1994, the instrument of ratification by the Government of Turkey of the above-mentioned Protocol was deposited with the Secretary-General.

With the deposit of the said instrument, the conditions provided for in article 8 (1) of the Protocol have therefore been met. Accordingly, the Protocol entered into force definitively on 25 March 1994.
