THE SECRETARY-GENERAL OF THE UNITED NATIONS,
acting in his capacity as depositary of the
Basel Convention on the Control of
Transboundary Movements of Hazardous Wastes
and their Disposal, concluded at Basel on 22
March 1989,

LE SECRETAIRE GENERAL DE L'ORGANISATION DES
NATIONS UNIES, agissant en sa qualité de
dépositaire de la Convention de Bâle sur le

WHEREAS it appears that in the original of
the Convention there is a lack of concordance
between the original Arabic, Chinese, English
and Spanish texts and the correct other
language versions of article 17 (5) of the
Convention,

CONSIDERANT que dans l'original de la
Convention apparaît un défaut de concordance
entre la version originale des textes
anglais, arabe, chinois et espagnol et les

WHEREAS the corresponding proposed
corrections were communicated to all States
concerned by depositary notification
C.N.1.1994.TREATIES-1 of 15 February 1994,

WHEREAS at the end of a period of 90 days

objection had been notified,

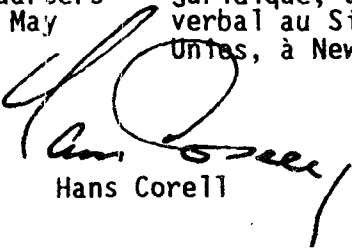
CONSIDERANT que dans le délai de 90 jours à

٥ - تودع صكوك التصديق على التعديلات أو الموافقة عليها أو إقرارها رسمياً أو قبولها لدى الوديع. ويبدأ نفاذ التعديلات المعتمدة وفقاً للفقرة ٣ أو ٤ أعلاه بين الأطراف التي قبلتها في اليوم التسعين من استلام الوديع للصك الخاص بالتصديق أو الموافقة أو الإقرار الرسمي أو القبول من جانب ما لا يقل عن ثلاثة أرباع الأطراف التي قبلت التعديلات، أو ما لا يقل عن ثلثي الأطراف في البروتوكول موضع الدراسة، عدا ما قد ينص عليه خلافًا لذلك في هذا البروتوكول. وتسري التعديلات فيما بعد على أي طرف آخر في اليوم التسعين بعد إيداع ذلك الطرف لصك التصديق على التعديلات أو الموافقة عليها أو إقرارها رسمياً أو قبولها.

第17条

5. 修正的批准、核准、正式确认或接受文书应交保存人保存。依照以上第3或第4款通过的修正，除非有关议定书里另有规定，应于保存人接得至少四分之三接受修正的缔约国或至少三分之二接受修正的有关议定书的缔约国的批准、核准、正式确认或接受文书之后第九十天，在接受修正的各缔约国之间开始生效。任何其他缔约国存放其对修正的批准、核准、正式确认或接受文书九十天后，修正对它生效。

Article 17

5. Instruments of ratification, approval, formal confirmation or acceptance of amendments shall be deposited with the Depositary. Amendments adopted in accordance with paragraphs 3 or 4 above shall enter into force between Parties having accepted them on the ninetieth day after the receipt by the Depositary of their instrument of ratification, approval, formal confirmation or acceptance by at least three-fourths of the Parties who accepted them or by at least two thirds of the Parties to the protocol concerned who accepted them, except as may otherwise be provided in such protocol. The amendments shall enter into force for any other Party on the ninetieth day after that Party deposits its instrument of ratification, approval, formal confirmation or acceptance of the amendments.

Artículo 17

5. Los instrumentos de ratificación, aprobación, confirmación formal o aceptación de las enmiendas se depositarán con el Depositario. Las enmiendas adoptadas de conformidad con los párrafos 3 ó 4 de este artículo entrarán en vigor, respecto de las Partes que las hayan aceptado, el nonagésimo día después de la fecha en que el Depositario haya recibido el instrumento de su ratificación, aprobación, confirmación formal o aceptación por tres cuartos, como mínimo, de las Partes que las hayan aceptado o por dos tercios, como mínimo, de las partes en el protocolo que se trate que hayan aceptado las enmiendas al Protocolo de que se trate, salvo si en éste se ha dispuesto otra cosa. Las enmiendas entrarán en vigor respecto de cualquier otra Parte el nonagésimo día después de la fecha en que esa Parte haya depositado su instrumento de ratificación, aprobación, confirmación formal o aceptación de las enmiendas.
