INTERNATIONAL AGREEMENT ON OLIVE OIL AND TABLE OLIVES,  
1986, AS AMENDED AND EXTENDED, 1993,  
CONCLUDED AT GENEVA ON 10 MARCH 1993EXTENSION OF THE TIME-LIMIT FOR DEPOSIT OF INSTRUMENTS  
OF RATIFICATION, ACCEPTANCE OR APPROVALAMENDMENT OF DESIGNATIONS AND DEFINITIONS IN  
ARTICLE 26, SECTION 1, PARAGRAPH A, SUB-PARAGRAPH (a)

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

## I

The International Olive Oil Council, by Resolution No. RES-1/70-IV/94 of 31 May 1994, adopted at Istanbul during its 70th Session of May/June 1994, decided in accordance with article 54, paragraph 1 of the above-mentioned Agreement and article 6 of the Protocol of 10 March 1993, to extend the time-limit for the deposit of the instruments of ratification, acceptance, approval of the Protocol or accession to the Agreement until 31 December 1994.

## II

At the same session, by Resolution No. RES-3/70-IV/94 of 3 June 1994, adopted by unanimous decision, in accordance with article 26 (3) of the above-mentioned Agreement, the International Olive Oil Council has decided to make certain amendments to the designations or definitions in the aforesaid article 26, section 1, paragraph A, sub-paragraph (a).

The text of article 26, as modified, of the Agreement in the English, French, Italian, Spanish and Arabic languages is attached ..... herewith (Annexes A, B, C, D and E, respectively).
