EUROPEAN AGREEMENT ON IMPORTANT INTERNATIONAL COMBINED  
TRANSPORT LINES AND RELATED INSTALLATIONS (AGTC)  
CONCLUDED AT GENEVA ON 1 FEBRUARY 1991

ACCESSION BY SLOVENIA

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 1 November 1994, the instrument of accession by the Government of Slovenia to the above-mentioned Agreement was deposited with the Secretary-General.

In accordance with its article 10 (3), the Agreement entered into force for Slovenia on the ninetieth day after the date of deposit of the instrument, i.e. on 30 January 1995.
