RATIFICATION BY GREECE

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 26 April 1995, the instrument of ratification by the Government of Greece of the above Agreement was deposited with the Secretary-General.

In accordance with its article 10 (3), the Agreement will enter into force for Greece on the ninetieth day after the date of deposit of the instrument, i.e. on 25 July 1995.
